What is the overall deductible?	\$500 member/\$1,000 family	Generally, you must pay all of the costs from providers up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible?</u>	Yes. <u>Preferred Provider</u> services for <u>preventive care</u> , physician office visits, urgent care, LabCard, emergency room visits and <u>Preferred Provider</u> or <u>Non- Preferred Provider</u> services for non-specialty prescription drugs and child immunizations are covered before you meet your <u>deductible</u> .	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply.
