<p><b>What is the overall <a href="#">deductible</a>?</b></p>	<p><a href="#">Preferred Provider</a> \$1,500 member/\$3,000 family; <a href="#">Non-Preferred Provider</a> \$3,000 member/\$6,000 family</p>	<p>Generally, you must pay all of the costs from providers up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the policy, the overall family <a href="#">deductible</a> must be met before the <a href="#">plan</a> begins to pay.</p>
<p><b>Are there services covered before you meet your <a href="#">deductible</a>?</b></p>	<p>Yes. <a href="#">Preferred Provider</a> services for <a href="#">preventive care</a> and <a href="#">Non-Preferred Provider</a> services for child immunizations are covered before you meet your <a href="#">deductible</a></p>	<p>This <a href="#">plan</a> covers some items and services even if you haven't yet met the <a href="#">deductible</a> amount. But a <a href="#">copayment</a> or <a href="#">coinsurance</a> may apply. For example, this <a href="#">plan</a> covers certain <a href="#">preventive services</a> without <a href="#">cost-sharing</a> and before you meet your <a href="#">deductible</a>. <b>Will you pay less if you use a <u>network provider</u>?</b>	Yes. See <a href="http://www.nipponlifebenefits.com/member-service/">http://www.nipponlifebenefits.com/member-service/</a> or call 1-800-374-1835 for a list of <a href="#">preferred providers</a> .	This <a href="#">plan</a> uses a <a href="#">provider network</a> . You will pay less if you use a <a href="#">provider</a> in the <a href="#">plan's network</a> .
